# Meet the final bench

#### Kate O'Regan

Kate is the inaugural Director of the Bonavero Institute of Human Rights and a former judge of the South African Constitutional Court (1994 – 2009). In the mid-1980s, she practiced as a lawyer in Johannesburg in a variety of fields, but especially labour law and land law, representing many of the emerging trade unions and their members, as well as communities threatened with eviction under apartheid land laws. In 1990, she joined the Faculty of Law at UCT, where she taught a range of courses including race, gender and the law, labour law, civil procedure and evidence.

Since her fifteen-year term at the South African Constitutional Court ended in 2009, she has amongst other things served as an ad hoc judge of the Supreme Court of Namibia (from 2010 - 2016), Chairperson of the Khayelitsha Commission of Inquiry into allegations of police inefficiency and a breakdown in trust between the police and the community of Khayelitsha (2012 – 2014), and as a member of the boards or advisory bodies of many NGOs working in the fields of democracy, the rule of law, human rights, and equality.



#### Nani Jansen

Nani Jansen Reventlow is an internationally recognised human rights lawyer specialised in strategic litigation at the intersection of human rights, social justice, and technology. She is the founder of Systemic Justice, a new organisation that seeks to radically transform how the law works for communities fighting for racial, social, and economic justice. Previously, Nani founded and built the Digital Freedom Fund, which supports partners in Europe to advance digital rights through strategic litigation. There, she initiated a decolonising process for the digital rights field. She is also the initiator of the Catalysts for Collaboration project, which offers best practices and case studies encouraging activists to collaborate across disciplinary silos and use strategic litigation in digital rights campaigns.

Nani is Adjunct Professor at Oxford University's Blavatnik School of Government and an Affiliate at the Berkman Klein Center for Internet & Society at Harvard University. She has been an advisor to Harvard's Cyberlaw Clinic and an Associate Tenant at Doughty Street Chambers since 2016.



#### **Mark Stephens**

Mark Stephens specialises in international, appellate and complex human rights and media litigation, Mark Stephens has undertaken some of the highest profile cases in the country and abroad.

Mark is a solicitor with an expertise in constitutional, human rights, media & regulatory work, defamation, privacy, data protection and freedom of information.

Mark has been a Judge on the Price Media Moot since it began and has travelled the globe judging regional rounds. He also sits on the Advisory Board of Oxford University's Programme in Comparative Media Law & Social Policy, at Wolfson College and is Chairman of Internews.

## Meet the Semi Final judges



#### Freya Baetens

Freya is Professor of Public International Law at the Faculty of Law, University of Oxford, Head of Programmes at the Bonavero Institute of Human Rights, and Fellow at Mansfield College. She is also affiliated with the PluriCourts Centre of Excellence (Faculty of Law, Oslo University) and the Europa Institute (Faculty of Law, Leiden University). She has been a visiting professor at several universities around the world. Freya regularly acts as counsel or expert in international and European disputes before international tribunals and courts. She is listed on the Panel of Arbitrators and Conciliators of the International Centre for the Settlement of Investment Disputes (ICSID), the South China International Economic and Trade Arbitration Commission (Shenzhen Court of International Arbitration), and the Hong Kong International Arbitration Centre (HKIAC). She undertook her doctoral research at the University of Cambridge and holds LLB and LLM degrees from the University of Ghent (Belgium), and an LLM degree from the University of Columbia (USA).



#### **Antonina Cherevko**

Antonina is an experienced human rights lawyer and international development expert specialising in media law with a long-term professional and academic focus on the issues of freedom of expression and media policy. She has over 17 years of professional experience in international development and management of democratisation projects in the areas of human rights, media policy, and law reform. Antonina worked with organizations like the Council of Europe, International Media Support, and ARTICLE 19. She is currently a Senior Adviser with the Office of the OSCE Representative on Freedom of the Media. Antonina's thematic areas of expertise cover human rights, rule of law, regional politics and hybrid threats, policy analysis, and needs and risk assessment.

Antonina holds an MA in Law from the National University of Kyiv-Mohyla Academy in Ukraine and MSt in International Human Rights Law from the University of Oxford. In 2020-2021, she was a member of the Committee of Experts on Combating Hate Speech (ADI/MSI-DIS) of the Council of Europe. Between September 2020 and May 2022, Antonina served as a Head of the Independent Media Council in Ukraine.



#### **Richard Danbury**

Richard has been judging the Moot for over a decade, and is a member of the Advisory Committee of the Price Moot Competition. He is the Director of the MA in Investigative Journalism at City, University of London, and before that trained investigative journalists for the UK TV network Channel 4. A long time ago he was a barrister, then for a decade a staff journalist at the BBC, before he went freelance. His undergraduate degree is in philosophy from Cambridge, and his doctorate is in media law from Oxford, considering the place of institutional journalism in media law. He undertook post-doctoral research back at Cambridge into copyright and news. He is a member of the advisory board of Cambridge's Minderoo Centre for Technology and Democracy, an academic member of the Global Network Initiative, and a trustee of Internews Europe.

## Meet the Semi Final judges



#### **Maksym Dvorovyi**

Maksym is the Head of Digital Rights for Digital Security Lab Ukraine, an NGO advocating for a human-rights-centered digital environment in Ukraine. He is involved in several working groups drafting Ukrainian media and digital rights legislative amendments, from AVMSD implementation to online political ads regulation. Most recently, he co-drafted the Law on Media, an all-encompassing piece of legislation aimed at approximating Ukrainian media legislation to the EU and CoE standards. Previously, he worked as a parliamentary assistant to the Chair of the Verkhovna Rada of Ukraine Information Policy Committee and interned in the Parliament of Canada. Maksym has been with Price Moot since the 2014/15 season, progressing from the participant to the organizer role. He coached the International Rounds Runner-Up Team in 2018/19 from his alma mater, the National University of Kyiv-Mohyla Academy.



#### **Gillian Phillips**

Gillian is the Director of Editorial Legal Services for Guardian News & Media Limited (publishers of the Guardian and Observer newspapers and theguardian.com). She was educated at Selwyn College, Cambridge, and qualified as a solicitor in 1984 with the law firm Coward (now Clifford) Chance. She joined the BBC as an in-house lawyer in 1987, later working for News Group Newspapers and Times Newspapers. She moved to GNM in May 2009 and has advised on phone-hacking, Wikileaks, the Leveson Inquiry, the NSA leaks from Edward Snowden, and more recently the Panama Papers, the Pegasus Project, and the Uber files . She also sits as a part-time Employment Tribunal Judge and coauthors the College of Law Employment Law handbook. She is a non-resident fellow of the Centre for Media, Data and Society at the Central European University School of Public Policy, and holds an honorary law doctorate from London South Bank University.



#### Satyajit Sarna

Satyajit is a practising lawyer who has spent over a decade appearing before the courts in India in a wide range of matters. He has extensive first-hand experience defending against SLAPPs in courts in India, as part of a media law focused practice. He has defended publishers, writers, newspapers, and journalists against large businesses, motivated government actions, and powerful private organizations.

Sarna graduated from the National Law School of India University, Bangalore, India and holds an Advanced LLM in European and International Human Rights Law from Leiden University in the Netherlands.

He is a 2022-23 Re:Constitution Fellow, focusing on researching SLAPPs and the freedom of expression, as part of a wider project on democracy and the rule of law in Europe. He has recently completed a study visit to the European Court of Human Rights at Strasbourg. He is also a published writer and poet.



Kurulu, a state of about 50 million people, provides free primary, secondary, and tertiary education for its population, with the state maintaining a monopoly over university education. Due to a lack of resources, less than 20% of those completing secondary education are admitted to state universities.

Due to a lack of resources, less than 20% of those completing secondary education are admitted to state universities.

The Campaign for Private Education (CPE), an organisation of civil society activists and academics, argues that the state is denying citizens the right to tertiary education by preventing the establishment of private universities. The CPE and its head, Professor Swarna Shikra, a tenured professor at the National University of Kurulu (NUK), demand

that the University Standards Board Law be amended to permit privatelyowned universities. Kanthi Besra, a successful entrepreneur and Shikra's partner, is one of the CPE's largest benefactors and has promised to found the first private university if the law is reformed.

The Inter-University Students Union (IUSU) is a nation-wide organisation comprising student unions of 39 of the 40 state universities in Kurulu. The Student Association of the National University of Kurulu (SANUK) was expelled from the IUSU for its overt support of the CPE. A rival student union called the National University of Kurulu Students Union (NUKSU) was formed in 2020 and has publicly

opposed Shikra and SANUK. Its membership in IUSU is currently under consideration. The IUSU has consistently opposed private universities and has actively lobbied the government to maintain a monopoly over university education.

Chirp is Kurulu's most popular social media platform. In 2022, Chirp had over 23 million users in Kurulu. On Chirp, users can post images and videos along with a caption, and others users can 'follow' them and post comments in response. Users can also 'like' another user's post or comment and can share a post with others.

*Chirp*'s Community Guidelines provide for the removal of content

that contains credible threats, content that targets private individuals to degrade or shame them, and personal information meant to blackmail or harass someone.

*Chirp* has two mechanisms in place to deal with content that violates its Community Guidelines. First, since 2018, it uses an Artificial Intelligence (AI) mechanism to scan and analyse all content on Chirp for violations. An in-depth review of the AI mechanism's performance in 2020 concluded that the mechanism had an 88% 'accuracy rate' of correctly classifying content as either complying or violating the Community Guidelines. The mechanism was tweaked in September 2021 to ensure 'more robust debates on public issues' and improve accuracy rates. Secondly, *Chirp* employs 500 human content reviewers (downsized from 1000+ in April 2022) who perform reviews

of all user complaints. A user can 'report' any post or comment, indicating which Community Guideline was allegedly violated by the content.

While there is currently no legislation regulating social media platforms in Kurulu, the Constitutional Court held that private sector companies operating social media platforms have duties and responsibilities under the Constitution. In a 2016 case, the Court found that *Chirp* had violated a user's right to privacy where it failed to proactively detect and take down content harmful to the user.

#### **Events of 9 July 2022**

At 9:00 am on 9 July 2022, Shikra, who has over 200,000 followers on *Chirp* and whose posts can be viewed by all *Chirp* users, made a post about the lack of access to university education. **She posted:** 

"It's time for all academics and students to take a stand.

Until change comes: REFUSE to teach or attend classes;

OCCUPY all university premises. DO NOT TOLERATE traitors to the cause."

The post received over 15,000 'likes' and was shared several thousand times. However, a vast majority of those who commented on the post disagreed with Shikra. Many of the comments were hostile and were made by anonymous users.

On the same day, SANUK issued a statement on *Chirp* and on its official website endorsing Shikra's call for strike action. SANUK required all its members to comply with the directive for strike action and stated that "Strict action will be taken against non-compliance". The IUSU, on the other hand, condemned Shikra's post and demanded that she be removed from her university post for violating the university's Academic Code of Conduct.

At 8:00 pm that day, an anonymous user 'IUSU\_RedKite' posted: "This entire campaign is being funded by Shikra's lover, that evil neoliberal Kanthi Besra". Another user named 'BarnOwn\_NUKSU' posted immediately below: "What a pair of birdbrains. Trash their nest!" *Chirp*'s AI mechanism removed around 40 comments which called for physical harm against Shikra and Besra and their property. The posts by 'IUSU\_Redkite' and 'BarnOwl\_NUKSU' were not removed, and no user complained about them.

At 3 am the next morning, Shikra and Besra's home was broken into and vandalised. CCTV footage showed three individuals breaking open a window and entering the premises. One suspect spray painted 'BIRDBRAINS!' on a wall.

#### **Complaints and Inquiries**

On 10 July, Besra filed a complaint with the police and provided a screenshot of the comment by 'BarnOwl\_NUKSU', suggesting that this user might have been involved in the break-in. Besra also alleged that *Chirp* had failed to take reasonable action to prevent the crime from taking place. Following investigations, the investigating police officer concluded that *Chirp* had taken reasonable precautions and that liability, if any, would rest with the users concerned. The police applied for a warrant to obtain from *Chirp* any information regarding the identity of the user 'BarnOwl\_NUKSU', but the Magistrate Court denied the request. The police continued to investigate by other means, but without success.



On the same day, the Office of the Vice Chancellor at NUK wrote to Shikra informing her that she was under investigation for a breach of the Academic Code of Conduct and that an inquiry would be held in a week. At the inquiry, which was conducted by a panel of three senior academics appointed in accordance with the Code of Conduct approved by the University Standards Board, Shikra defended her post on the basis of 'academic freedom' protected under the Constitution.

The panel determined that Shikra's post violated the Code and recommended that she be suspended for a week, and that the lifting of her suspension be conditional on a written undertaking to refrain from issuing similar statements in the future. Shikra was subsequently suspended.

#### **Proceedings before the Constitutional Court**

On 20 July, Shikra and Besra filed a joint petition before the Constitutional Court against the State of Kurulu and *Chirp*. They alleged that the State of Kurulu failed to provide them an effective remedy against the violation of their rights to privacy and freedom of opinion and expression under the constitution by private actors by failing to properly investigate the crime that had taken place on 10 July and failing to direct *Chirp* Enterprises to disclose the personal details of suspects involved in the crime. They also alleged that the State violated their rights by failing to impose reasonable statutory duties on private actors such as *Chirp* Enterprises to remove harmful online content.

Shikra and Besra also contended that *Chirp* Enterprises failed to proactively detect and take down harmful content resulting in real world physical harm to them, which amounted to a violation of their freedom from interference with their privacy and home and affected the exercise of their freedom of opinion and expression.

In a separate petition, Shikra complained that the National University of Kurulu had violated her constitutional rights to freedom of opinion and expression and academic freedom through her suspension and the conditions attached to the removal of her suspension.

#### The Constitutional Court dismissed both petitions.

Having exhausted all domestic remedies, Shikra and Besra now seek declarations from the Universal Court of Human Rights that their rights under Article 17 and Article 19, read with Article 2(3) of the ICCPR, have been violated.

# Legional Control of the State o

This year saw a total of 85 teams registering their participation across 7 regions (Africa, Central Eastern Europe, Asia Pacific, South Asia, Northern Europe, Americas, Middle East). Teams participated with enthusiasm with some rounds taking place in person and some virtually and we received tremendous support from our regional coordinators and judges around the world. Once again, without them the Competition could not take place.

A total of 29 teams qualified for the International Rounds of the Moot. We had hoped to welcome teams, coaches, and judges from around the world to Oxford but this was not possible - we hope that the experience remains just as valuable and exciting on our virtual platform.
