It has been five years since the moot final rounds were held in Oxford. We have been looking forward to this for a long time. Congratulations to all of you who have qualified. It is a great achievement to have reached the final rounds. Juliana da Cunha Mota

Juliana is a DPhil candidate in Law at the University of Oxford. Juliana's research focuses on the adjudication of informational privacy rights in Europe. She holds an LL.M from the University of Cambridge. Juliana is a qualified lawyer in Brazil and worked for three years in the practice of law and technology at a law-firm. Juliana is a moot enthusiast, having argued, coached, judged, and organised many moot court competitions the past ten years.

Kate O'Regan

Kate is the inaugural Director of the Bonavero Institute of Human Rights and a former judge of the South African Constitutional Court (1994 – 2009). In the mid-1980s, she practiced as a lawyer in Johannesburg in a variety of fields, but especially labour law and land law, representing many of the emerging trade unions and their members, as well as communities threatened with eviction under apartheid land laws. In 1990, she joined the Faculty of Law at UCT, where she taught a range of courses including race, gender and the law, labour law, civil procedure and evidence.

Since her fifteen-year term at the South African Constitutional Court ended in 2009, she has amongst other things served as an ad hoc judge of the Supreme Court of Namibia (from 2010 – 2016), Chairperson of the Khayelitsha Commission of Inquiry into allegations of police inefficiency and a breakdown in trust between the police and the community of Khayelitsha (2012 – 2014), and as a member of the boards or advisory bodies of many NGOs working in the fields of democracy, the rule of law, human rights, and equality.

Mark Stephens specialises in international, appellate and complex human rights and media litigation, Mark Stephens has undertaken some of the highest profile cases in the country and abroad.

Mark is a solicitor with an expertise in constitutional, human rights, media & regulatory work, defamation, privacy, data protection and freedom of information.

Dr. Khalifa is the coordinator of the Middle East Rounds of Oxford Price Media Moot Court Competition. Dr. Khalifa is an expert consultant with the ICRC in the MENA region, and he serves also as a consultant with several international organizations including the United Nations Office on Drugs and Crime (UNODC) in the MENA Region and the United Nations Children's Fund (Unicef). Previously, he served as a full time in-house legal consultant with the United Nations Interregional Crime and Justice Research Institute (UNICRI), Torino, Italy. Dr. Khalifa obtained his Phd in International Criminal Law from Poitiers University in France after finishing his LLM focusing on International Human Rights Law from Temple University, USA. His areas of research covers international criminal law, international humanitarian law and International human rights law.

Adriana Minovic

Adriana is a lawyer specialized in the Regulatory & Compliance domain (specifically Data Protection, IT&AI Governance, Intellectual Property, Competition Law, AML, and Anti-Corruption) in a wide portfolio of innovative and data-driven industries: ICT, Telecom, Media, R&D, i-Gaming, Aviation, and Life Science. Ahmed Rashwan

Ahmed is a public prosecutor at the Egyptian Public Prosecution. His interests span criminal law, international law, human rights law, and public law. He obtained his LL.B. from Ain Shams University and his LL.M. from the University of Cambridge. Currently, he is pursuing a MA in Philosophy at the American University in Cairo.

Alec Freund SC

Alec is a South African advocate (barrister). After brief stints at the sidebar and academia, he commenced practice as an advocate in 1988. He was awarded Senior Counsel status (equivalent to King's Counsel) in 2006. In the early years of his practice, most of his clients were the then-emerging black trades unions. After the advent of democracy in the 1990's, his practice broadened considerably, and has mainly been in the fields of administrative, employment, pension and constitutional law, as well as more general commercial law. Administrative law has taken him to a wide variety of fields, including frequently advising the South African financial regulator. He has argued cases - many of them reported - in most Southern African courts, including South Africa's Constitutional Court, Supreme Court of Appeal, High Courts, Labour Appeal Court and Labour Court; Botswana's Court of Appeal; and a number of administrative and employment tribunals. In recent years he has advised government agencies on addressing corruption in the public sector and served as counsel to a judicial commission of inquiry on this issue. He has on numerous occasions served as an acting (temporary) judge in the South African Labour Court and the High Courts located in Johannesburg and Cape Town. He also serves from time to time as an arbitrator or mediator. Though he now lives in Oxford, he remains a member of the Cape Town bar (practising mainly online)."

Alexander Kashumov

Alexander is a human rights lawyer. He is Executive Director of the Access to Information Program – Bulgaria where he has worked for the last 27 years. He has litigated hundreds of freedom of expression, access to information and other human rights cases before national and international tribunals including the ECtHR (Kasabova, Idakiev, Sashov, Hadzhiev, Boykanov, Aneva and Others, Yonchev, National Movement Ekoglasnost, Ekimdzhev and Others v. Bulgaria, and filed amicus briefs on behalf of AIP in Mosley and GC Magyar Helsinki, Satakunnan Markkinapörssi Oy etc.). He is also author and co-author of five books, many chapters in books, analyses, articles, handbooks, and an international expert, trainer, lecturer and consultant on EU, CoE and other projects. He is SC member of the FOI Advocates network, a member of the Journalist Ethics Commission in Bulgaria (2006- up to now) and its former president, and a member of the Bulgarian Supreme Bar Council. Alexander Kashumov was recognized as "Attorney of the Year" in 2008 and received "Top case" award in 2016.

Alexander Willingham

Alexander is a practising in-house Commercial Lawyer at Sainsbury's in London. He holds an undergraduate LLB degree and an LLM in Commercial and Corporate Law from Queen Mary, University of London which focused heavily on Media and Privacy Law. He was a member of the Queen Mary, University of London, Semi-Finalist team at the Monroe E. Price Media Law Moot Court Competition International Rounds ten years ago and has been a judge in the competition since then.

Aly AbdelBary

Aly is a prosecutor at the Egyptian Public Prosecution Office. He obtained his Master of Advanced Studies (LL.M) in International Humanitarian Law and Human Rights from the Geneva Academy, and his Bachelor of Laws (LLB) from Ain Shams University. Mr. AbdelBary has participated as a judge in the Price Moot Court International Rounds since 2019. He has served as a teaching assistant of public international law at Ain Shams University where he has taught public international law and international organizations' law. Aly's experience has included working in the UN system as a research assistant at the International Law Commission in its seventy-fourth session as well as a part-time graduate professional at the UN Institute for Disarmament Research. His main research interests are international humanitarian law, international criminal law, and human rights law.
