# Oxford Intellectual Property Research Centre Annual Report for Academic Year 2016-17

The coming year will see the tenth anniversary of the Centre's move to the Faculty of Law from St. Peter's College. In that time, intellectual property has assumed an ever-more visible presence in the teaching and research activities of the Faculty. The Centre has become an integral part of the Faculty without losing its multi-disciplinary character; and this integration is now physically manifested by the suite of Centre offices in the redeveloped St. Cross building. That space includes not only offices for the Director and the Centre's administrative staff, but also offices for the ever-greater number of visiting researchers who wish to spend time with us in Oxford.

In recent years, the activities of the Centre have become ever more global in reach. We have partnered with numerous institutions from North America, Europe, Australia and Asia to organise major conferences and research workshops. These have taken place both in Oxford and abroad. The foreign sojourns in the past year included a tremendously productive workshop with Indiana University-Bloomington in the United States on design protection, and a high-profile conference on design law reform held in Singapore in partnership with the National University of Singapore (NUS). The Indiana workshop afforded some of our growing number of graduate research student members an opportunity to interact intensively with established US and European academics. And the Singapore conference, which brought together academics, policymakers, industrial designers, and legal practitioners, drew heavily for organization and speakers upon leading practitioners from the Intellectual Property Lawyers Association (IPLA). We have now partnered with the IPLA for a decade in teaching the Oxford Postgraduate Diploma in Intellectual Property Law & Practice (IP Diploma) and it is a welcome development that we now also count some of those colleagues as Research Fellows of the Centre.

In combination with these kinds of activities, and the immense success and growth of the Oxford International Intellectual Property Moot, the Centre now enjoys a robust international footprint. This helps not only to draw top international students and researchers to Oxford (to our mutual enrichment) but also facilitates the extended reach of our individual and collective research.

Our collaboration with NUS will also within the next few weeks result in substantial published work product, namely, a dedicated issue of OUP's flagship Journal of Intellectual Property Law & Practice. And the coming months will also see the publication of a Centre Study on Voluntary Registration & Deposit Systems in the United States and China, which was prepared for the European Union Intellectual Property Office (EUIPO) under a grant awarded to the Centre. The success of that Study should be the foundation for future research work funded by the EUIPO.

This highlighting of (just some of) the activities of the Centre in the last year, while satisfying, also reveals a continuing challenge. The number of permanent Law Faculty postholders involved in the work of the Centre is comparatively modest. This feature of IP at Oxford creates pressure in the first instance on teaching, examining and supervision. But this also has implications for the research work of the Centre; we are heavily dependent upon the Research Fellows of the Centre who are not based at Oxford, on our colleagues in non-law disciplines, and on our talented group of graduate research students.

The annual Moot and Conversazione are central to the Centre's year, but would not be possible without the efforts of Dr Emily Hudson and Dr Barbara Lauriat, respectively, both of whom are senior Lecturers at KCL. The development of the NUS Conference and publication of the proceedings was led by David Stone, who heads the Global Brands group at Allen & Overy and

is a Deputy High Court Judge. The EUIPO Study and our collaboration with Indiana depended heavily on the important contributions of several graduate research members.

In some respects, this is what makes the Centre a special place. It is a delight to work and interact with this varied group of academics, practitioners and students. The constant reinvigoration from outside is an important part of what makes our scholarly community vibrant; and the range of engagement with Research Fellows and visiting researchers from all over the world can be seen again in this year's annual report. But the job of the Director in coordinating all of these moving parts requires a substantial amount of administrative time, and there is of course similar important work to be done on other IP matters on the Faculty (most notably, on the Diploma). Without our two stellar administrative colleagues, it would be impossible. Even with them, it presents serious challenges.

Despite these challenges, the Centre has thrived. As Director of the Centre, I am very grateful to all those who have supported our activities during the past year, both within the university and beyond. The sources of funding that have sustained these activities are as diverse as the activities. We are very grateful to external funders who have supported what we do, including 8 New Square, Allen & Overy, Cambridge University Press, Edward Elgar Publishing, Hart Publishing, Herbert Smith Freehills, Powell Gilbert, Thomson Reuters, the European Union Intellectual Property Office, the Intellectual Property Office of Singapore, and the British High Commission in Singapore. The funders of each of our events are listed below.

2018 will see an important step towards the Centre's future. After having been Director of the Centre for nine years, I will step down from the post and from the Chair in Intellectual Property Law when I return to the United States to take up a new role as Global Professor of Intellectual Property Law at Chicago-Kent College of Law.

It has been a privilege to serve in this Faculty office for so many years and I am tremendously grateful to all the Centre's staff, friends and supporters who have made possible what we have achieved in the past nine years. I am particularly grateful to Ellen Moilanen, IP Administrator, and Jenny Hassan, Administrative Assistant to the IP group, for their excellent professional support for almost all these years. The Centre would not have been able to achieve anything without their hard work, and the work would not have been nearly as enjoyable without their positive and cheerful demeanour even when presented with challenges.

I am delighted that the Faculty has appointed Professor Dev Gangjee to the Directorship from Hilary Term. I could not think of any Faculty colleague better suited to lead the Centre going forward.
