Border Criminologies is pleased to announce an open call for paper submissions to our [SSRN 'Criminal Justice, Borders & Citizenship Research Paper Series'](#).

The Series is a cooperation between the [Centre for Criminology](#) (University of Oxford), the [Border Crossing Observatory](#) (Monash University), the [Department of Criminology and Sociology of Law](#) (University of Oslo) and the [Leiden Law School](#) (Leiden University). It is a platform that showcases interdisciplinary research on the intersections between criminal justice and migration control, making all papers freely available. It mainly has two objectives: promoting co-operation in research and education between faculties at all universities involved, and thereby leverage Oxford's assets as a centre of excellence in the study of migration control; and offering a forum for dialogue and exchange on urgent questions concerning the dynamics and direction of criminal justice and border control. The Series' core affiliates represent a wide variety of academic disciplines from the Social Sciences, Law and Humanities.

We now have more than **260 papers** on our series. Distribution of the paper exceeds 2,000 recipients, increasing exposure for the research significantly. Indeed, our distributed research papers series has tripled the download counts of all the papers included in them. Since May 2014, our papers have been downloaded over **48.000 times**. In 2018, our page was visited 20,500 times and our papers were downloaded 4,300 times reaching out to a vast number of countries around the world, including Iran, Hong Kong, Korea, India, Iraq, Israel and Ghana. Only in January 2019 our page was visited 4,180 times and our papers were downloaded 523 times.
